Assumption of Risk and Liability Release (waiver)



YOU MUST FIRST READ THE FOLLOWING: *Culebra Service and Rental LLC (d/b/a Gammy's Water Tours, or the "company") is a limited liability company dedicated to providing water taxi transportation services to and from the island municipalities of Culebra, Vieques, Fajardo and their nearby areas. These transportation services consist of being transported on a boat from one point to another, usually from one dry dock to a beach, from a beach to a dock, a dock to another dock or from a beach to another beach. THIS WATER TRANSPORTATION ACTIVITY IS AN INHERENTLY RISKY AND DANGEROUS ACTIVITY; THEREFORE, IT IS VERY IMPORTANT THAT YOU UNDERSTAND WHY AND FOLLOW ALL COMPANY RULES AND THE CAPTAIN'S INSTRUCTIONS AT ALL TIMES. WHY? – Because on a boat there usually are no seatbelts and the boat is constantly moving due to waves, wind and/or currents; you might feel seasick, dehydration, sunburn, prolonged exposure to the sun, excessive heat, rain, wind, and waves often in sudden, unpredictable, or uncontrollable conditions. While aboard, you and your minors must always wear lifejackets. You and/or your belongings might get wet and/or fall overboard. Any belongings you bring on board are your sole responsibility to hold, keep and protect, at your own risk, since they might get wet, damaged, stolen, blown away or fall overboard along the way. While boarding and offboarding, you and/or your belongings might also fall overboard. Boarding and offboarding from a dock usually takes place without a ramp or ladder, directly on to the boat, therefore, some amount of physical strength, balance and coordination might be required to board and offboard the boat. If you feel physically unable to do so, please let your captain know immediately. Meanwhile, boarding and offboarding from a beach usually takes place directly on to the water near a beach in shallow waters usually 2-4 feet deep, in which case you might only do so by using the boat's designated stairs, steps or ladder, or other area indicated by your captain. You might not jump directly on to the water from any side of the boat because the water might not be deep enough, there might be rocks or a reef, that part of the boat might not be suitable for boarding or offboarding, not all underwater conditions are visible from the boat, and for various reasons it might not be safe for you to jump or board. If you board or offboard the boat in any way other than that allowed or indicated by the company and your captain, any such actions will be entirely at your own risk and responsibility. In general, damages to your person, minors or belongings resulting from any of these risks inherent to this water transportation service are not covered or insured by the company or its insurers. The company's insurance policies only cover damages resulting from the company's negligent acts or omissions during the water transportation service; the company is not responsible for any other damages. Any damage or event that occurs outside the boat is also outside the limits of the insurance policy coverage and/or liability of the company and its insurers. If you are transported to a location, the company is not obligated to pick you up again unless you prepay and schedule a return service, if not, there is no guarantee you will find a ride back either with the company or other. The company might have snorkeling equipment, kayaks, paddle boards, chairs, umbrellas, and other items, available for the passengers to use, free of charge, at the passenger's own discretion and risk; the company does not provide any training and/or instruction for their use. Additionally, the use of this equipment might pose similar inherent risks to those of the water transportation service due to exposure to the sun, heat, waves, currents, winds, and other natural elements, plus the risks inherent to such equipment use. ***We recommend you drink water, wear SPF clothing and use sunscreen.****
